Fall River Electric is offering incentives for window replacement in existing multi family homes with primary any electric heat. A description of primary heating source (electric forced air furnace, zonal, heat pump, or ductless heat pump).

Here's how to qualify for the rebate:

- Step 1: Contact the Conservation Specialist at Fall River Electric prior to starting your project and schedule a **pre-inspection**. Rebate amounts are for the listed price per square foot of window(s) or patio door(s) replaced.
- Step 2: Install qualifying window(s) or patio door(s). Prime window replacement must meet requirements and have a qualifying U-Factor. **Replacement installation that results in increased window area is not allowed under this program.**
- Step 3: Contact Fall River Electric for post-inspection.
- Step 4: Provide Fall River Electric with a copy of the replacement window(s)/patio door(s) invoice, and the NFRC stickers showing the U-Factor rating for each window(s) or patio door(s) installed.
