Fall River Electric is offering incentives for window replacement in **existing single family or existing manufactured homes with primary electric heat** (This includes electric forced air furnace, radiant ceiling cable, baseboard, electric wall, electric boiler/hot water hydronic raditant, electric heat pump, or ductless heat pump).

To receive your rebate, simply follow these steps:

Step 1. Contact FRE Conservation Specialist prior to starting your project to schedule an Energy Audit. Pre-Inspection is a requirement prior to all installations.

Step 2. Install qualifying window(s) or patio door(s) according to the 2016 BPA Weatherization Specifications. Prime window replacement must meet requirements and have a qualifying U-Factor of 0.30 or less. Replacement that results in increased window area is not allowed under this program.

Step 3. Contact FRE Conservation Specialist for post-installation inspection.

Step 5. Provide FRE with completed rebate application, copies of the final invoice(s) and/or receipt(s), showing the manufacturer, model number, size, quantity and NFRC rating. If invoice does not show NFRC rating, stickers showing the U-Factor rating for each window(s) or patio door(s) will be required.
